#### **REQUIREMENTS FOR ABSTRACT FORMATTING**

1. Only original abstracts containing previously unpublished research results will be accepted for publication.

2. Abstract length should not exceed 5 pages, including figures, tables, and reference list.

3. Abstracts should be prepared using Microsoft Word, Times New Roman font; size -12; line spacing -1.15. Margins: 2 cm on all sides.

4. When formatting the reference list, follow the requirements of the National Standard of Ukraine DSTU 8302:2015. In-text citations should be indicated in square brackets.

5. Header elements: in the first line on the left without indentation – UDC; second line - surname and initials of the author(s); third line - academic title, scientific degree, position, institution (organization), email; fourth line - author's ORCID (if available); after one blank line - the title of the abstract in capital letters (centered). Then, after one blank line – an annotation. On a new line – keywords in the language of the abstract. On a new line – the main text. One blank line after the abstract text should be followed by "References". At the end, for Ukrainian-language abstracts, the following should be provided in English: surname and initials of authors (centered), abstract title (centered, in capital letters), translation of the annotation text and keywords (from a new line, paragraph indentation); for English-language abstracts – all data should be duplicated in Ukrainian.

6.Abstract files and application files should be saved in DOC format. File names should be submitted as: Ivanenko abstract, Ivanenko application.
